Subject - Intimation under Regulation 30 read with Schedule III of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("SEBI Listing Regulations")

This is further to our letter dated June 12, 2024, informing the Stock Exchanges about Writ of Mandamus filed by the Company before the Hon'ble High Court of Madras under Article 226 of the Constitution of India vide Writ Petition No. WP.15406/ 2024 dated June 11, 2024 against Tamil Nadu Medical Services Corporation Limited ("TNMSC") pursuant to Regulation 30 of the SEBI Listing Regulations read with SEBI Circular No SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023.

The Company would like to inform that it has received an Order no. 2024: MHC: 2288 on June 15, 2024 passed by Hon'ble High Court of Madras on June 12, 2024. Following are synopsis of the order.

TNMSC has floated a tender for outsourcing of housekeeping and security services in 123 Government Hospitals, Colleges and Schools and Colleges of Nursing on July 26, 2023. 13 bidders, including M/s Krystal Integrated Services Limited had participated in the above tender and after evaluation of the technical bids, TNMSC has published the result of evaluation of the technical bid on April 30, 2024 in their website wherein out of the 13 bidders, 9 bidders including M/s Krystal Integrated Services Limited were found to be qualified and M/s Krystal emerged as L2 bidder.

There are several violations of the tender conditions, discrepancies and irregularities in the price schedule (Format F) and the consolidated Summary Cost for manpower for all the hospitals and resource cost equipment/consumables for all hospitals covered in all zones reveals that the bid submitted by Quality Property Management Services Pvt. Ltd. has engaged in an unfair bidding practice and has made non-compliant/ speculative bidding contrary to the terms of the tender and its corrigenda.
