We wish to inform you that the matter of non-compliance with the provisions of Regulation 18(2)(b) of SEBI Listing Regulations *i.e.* Audit Committee quorum at the meeting held on May 13, 2024, was placed before the Board of Directors at their meeting held on April 30, 2025.

The Board discussed and took note of the matter of non-compliance.

After due analysis and deliberation, the Board noted that the delay in compliance was inadvertent and unintentional. The Company made all possible efforts to fill the vacancy caused due to resignation of Mr. Vijay Agarwal (DIN 00058548) Independent Director and Chairperson of the Audit Committee.

Considering the level of competency, skills, experience and seniority required for Audit Committee, it took a reasonable 6 days' time to identify and finalize potential candidates. After a diligent selection process, Dr. Yajyoti Digvijay Singh (DIN 07971678), Independent Director was inducted as a member of Audit Committee and Professor Sunder Ram Govind Raghavan Korivi (DIN 01590692), Independent Director was appointed as the Chairperson of Audit Committee.

The Board emphasized that going forward prescribed timelines & compliances should be strictly adhered to.
