We refer to our appointment as the Statutory Auditors of Krystal Integrated Services Limited ('the Company') pursuant to shareholders' resolution dated December 30, 2020 to hold office for a period of 5 consecutive years.

We have completed our Statutory Audit in respect of Financial Statements for the year ended March 31, 2024 and issued our Audit Reports related to the Audit of Standalone and Consolidated Financial Statements on May 27, 2024 and are in the process of carrying out the limited review in respect of standalone and consolidated financial results for the quarter ended June 30, 2024.

We refer to our discussions with the management from time to time and also our communication wherein we emphasised onto the recent listing of the company, increase in the operations of the Company, increased work due to consolidation of financial statements and various regulatory compliances. This is resulting in performing additional audit procedures, additional efforts and additional responsibilities on the firm.
