Instead of transferring these funds to the Monitoring Agency account of the Company, these funds were transferred and utilized from its CC account and current account to facilitate operational efficiency. As at the end of the reported quarter, the unutilized net proceeds of Rs 242.50 million has been deployed in fixed deposits, leaving no balance pertaining to net proceeds in its cash credit account and current account.

Note 1: On the basis of the management undertaking and Certificate dated April 25, 2025, issued by M/s Mahendra Doshi & Associates, Peer reviewed Independent Chartered Accountant (Firms' Registration No. 105765W) , Till FY25, an amount of Rs 533.69 million was expected to be utilized towards the object "Funding capital expenditure for purchase of new machinery and GCP " by the Company as per the implementation schedule disclosed in Prospectus dated March 19, 2024. However, the Company has utilized Rs 291.19 million during the said fiscal towards the aforementioned objects and hence Rs 242.50 million remains unutilised as at the quarter ended March 31, 2025. The board has accorded its consent to incur the unutilised balance of GCP during FY 26 towards catering business, advertisement and working capital.
